AN ORDINANCE ACCEPTING
NATASHA L. WERNZ & MARK MEINGASNER
PETITION FOR ANNEXATION TO THE CITY OF MARSHALL, ILLINOIS

WHEREAS, pursuant to Section 7-1-8 of the Illinois Municipal Code (65 ILCS 5/7-1-8) there has been filed by Natasha L Wernz and Mark Meingasner with the City Clerk of this City a Petition for Annexation to the City of Marshall, Clark County, Illinois, of the real estate located at 1107 Vine Street, Marshall, Illinois, 62441 and described as follows:

A part of the Northwest Quarter of the Northeast Quarter of the Southeast Quarter of Sec.24, T11N, R12W at the 2nd P.M., Clark County, IL, described as follows: Commencing at a point 355.50ft. East of the Northwest corner of the Northeast Quarter of the Southeast Quarter of Sec.24; thence deflect Southerly with an interior angle of 89 degrees 51' for a distance of 202.00ft.; thence deflect Westerly with an interior angle of 90 degrees 09' for distance of 188.101ft.; thence Northerly with an interior angle of 90 degrees 25' for a distance of 202.00ft.; thence deflect Easterly with an interior angle of 89 degrees 35' along the North line of the Northeast Quarter the Southeast Quarter of Sec.24, for a distance of 190.10ft. to the place of beginning; subject to road right-of-way as shown in Plat recorded in Plat Record 4, page 408, in the Office of Recorder, Clark County IL., together with all rights and easements appurtenant there to and together with all grantor's right, title, and interest in sewer easement from Fred Willfond and Mildred Willfond extending Westerly to 11th Street for benefit an appurtenant to the above described premises, situated in the County of Clark, State of Illinois.

The above described property index number is 08-08-24-16-401-002 and has a physical address of 1107 Vine Street, Marshall Illinois 62441;

and

WHEREAS, said Petition was signed by the sole owner of record of the above described real estate; and

WHEREAS, 51% of the electors residing thereon have signed the Petition; and

WHEREAS, said real estate is not now a part of any municipality; and

WHEREAS, said real estate constitutes an area in Clark County, Illinois, contiguous to the municipality of Marshall, Clark County, Illinois; and

WHEREAS, said Petition contains an accurate description of the area sought to be attached and a statement that the signer thereof desires the property to be attached and annexed to the City of Marshall, Clark County, Illinois; and

WHEREAS, this Council has examined said Petition and found the same in due form and in compliance with the law; and

WHEREAS, said real estate is part of the Marshal Fire Protection District but that the City of Marshall does not provide fire protection service so that notice pursuant to Section 7-1-1 of the Illinois Municipal Code (65 ILCS 5/7-1-1) is not required; and

WHEREAS, said real estate is part of the Marshall Area Public Library District and that notice to the Trustees of said Public Library District has been provided in writing by certified or registered mail at least ten days prior hereto pursuant to Section 7-1-1 of the Illinois Municipal Code (65 ILCS 5/7-1-1); and

WHEREAS, it is proper that such proposed area be attached to and annexed to the City of Marshall; and

WHEREAS, the corporate authorities of the City of Marshall find it to be in the best interest of the City of Marshall to annex said real estate.

NOW THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARSHALL, CLARK COUNTY, ILLINOIS, AS FOLLOWS:

I. That the real estate herein before described, together with all highways adjacent thereto or contained therein, be and the same is hereby accepted for attachment and annexation to the City of Marshall, Clark County, Illinois, and the same is hereby attached and annexed.

II. That the clerk cause the original Petition for Annexation to the City of Marshall, Illinois, heretofore filed with this Council and a certified copy of this Ordinance with an attached Plat to be recorded with the County Clerk of Clark County, Illinois.

III. That notice of annexation to the county election authority be given by the recording of the certified copy of this Ordinance with the County Clerk, Clark County, Illinois.

IV. That this ordinance shall be published in pamphlet form and shall take effect ten (10) days after its passage, approval and publication in pamphlet form as provided by law.
