AN ORDINANCE APPROVING A PRELIMINARY PLAT
FOR THE DON BOWEN SUBDIVISION

WHEREAS, pursuant to sworn Petition for preliminary plat executed by Don & Janice Bowen and pursuant to Notice of Hearing published at least fifteen (15) days nor more than thirty (30) days before the date of hearing, the Zoning Commission held a public hearing; and

WHEREAS, No written objections were filed to the Petition; and

WHEREAS, the zoning commission has recommended that the Petition for the preliminary plat be approved; and

WHEREAS, the City Council has approved said Petition by majority vote.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARSHALL;

All of lot Ten (10) in Stephen Archer's Addition to the Town (now City) of Marshall, Clark County, Illinois.

SUBJECT to road rights of way, waterways, easements, reservations, exceptions and limitations in use, existence or of record, if any.

The above described property index number is 08-08-24-19-401-001.

The preliminary plat be approved referred to in Article IV of the Code of Ordinances of the City of Marshall.

That this Ordinance shall be published in pamphlet form and shall take effect ten (10) days after its passage, approval and publication in pamphlet form as provided by law.


