AN ORDINANCE AMENDING CHAPTER 86. UTILITIES. ARTICLE IV. WATER SERVICE. SECTION 86-107. CHARGES AND RATES FOR WATER SYSTEM. (2). GENERAL SERVICE: a.

BE IT ORDAINED by the City Council of the City of Marshall, Illinois:

Section 1. That Chapter 86. Utilities. Article IV. Water Service. Section 86-107. Charges and Rates for Water System. (2). General Service: a. of the Code of Ordinances, City of Marshall, Illinois is hereby amended to read as follows, with strikeouts indicating deletions in text and underscores indicating additions to text:

(2) *General service:*

a. For general service users inside the city limits, the charge shall be:

<i>Gallons per month</i>	<i>Rate per 1,000 gallons</i>
First 1,000	\$7.84
Next 39,000	5.00
All over 40,000	3.96

The minimum water service charge per month shall be the water service charge for the first 1,000 gallons used per month.

Commencing with the first billing date for each user after July 1 of each year, there shall be a ~~five~~ three percent increase to each of the water service charge and the minimum water service charge per month in effect prior to increase.

Section 2. If any provision of this Ordinance, or application thereof, is held invalid by any Court, other provisions or applications of this Ordinance which can be given effect without the invalid provision or application shall not be affected, and to this end the provisions of this Ordinance are declared to be severable.

Section 3. That this Ordinance shall be published in pamphlet form and shall take effect ten (10) days after its passage, approval and publication in pamphlet form as provided by law.
