AN ORDINANCE WAIVING AUTOMATIC INCREASE SET FORTH IN CHAPTER 86, UTILITIES. ARTICLE IV. WATER SERVICE. SEC. 86-107. CHARGES AND RATES FOR WATER SYSTEM.

BE IT ORDAINED by the City Council of the City of Marshall, Illinois:

WHEREAS, Chapter 86, Utilities. Article IV. Water Service. Sec. 86-107. Charges and rates for water system of the City of Marshall Code of Ordinances provides for an annual automatic increase of water service rates of three percent as of July 1 of each year, and;

WHEREAS, it is the opinion of the City Council of the City of Marshall that said automatic increase is not required for this calendar year;

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARSHALL, CLARK COUNTY, ILLINOIS THAT THE COUNCIL HEREBY WAIVES THE AUTOMATIC RATE INCREASE OF THREE PERCENT SET FORTH IN SECTION 86-107 OF THE CITY OF MARSHALL CODE OF ORDINANCES FOR THE PERIOD OF JULY 1, 2016 THROUGH JUNE 30, 2017.

Section 2. If any provision of this Ordinance, or application thereof, is held invalid by any Court, other provisions or applications of this Ordinance which can be given effect without the invalid provision or application shall not be affected, and to this end the provisions of this Ordinance are declared to be severable.

Section 3. That this Ordinance shall be published in pamphlet form and shall take effect ten (10) days after its passage, approval and publication in pamphlet form as provided by law.
