AN ORDINANCE AUTHORIZING THE SALE OF A 1989 MCGRAW-EDISON TRANSFORMER

BE IT ORDAINED by the City Council of the City of Marshall, Illinois:

WHEREAS, the City of Marshall is the owner of a McGraw-Edison Transformer serial number C-46541-1-1 with a rating of 12,000 kva; and

WHEREAS, it is the opinion of the City Council of the City of Marshall that said transformer is no longer necessary or useful to retain, or in the best interest of the City to retain;

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARSHALL, CLARK COUNTY, ILLINOIS THAT THE CITY OF MARSHALL HEREBY APPROVES AND AUTHORIZES THE 1989 MCGRAW-EDISON TRANSFORMER, SERIAL NUMBER C-46541-1-1 TO THE CITY OF CARMi FOR THE SUM OF \$25,000.

Section 2. If any provision of this Ordinance, or application thereof, is held invalid by any Court, other provisions or applications of this Ordinance which can be given effect without the invalid provision or application shall not be affected, and to this end the provisions of this Ordinance are declared to be severable.

Section 3. That this Ordinance shall be published in pamphlet form and shall take effect ten (10) days after its passage, approval and publication in pamphlet form as provided by law.
